7. RESEARCH IN PROGRESS

A. MONOGRAPH

How did the Middle East achieve economic growth: Money, wages, and trade

Abstract: Did the medieval economy grow and how to measure it? Based on previous research I continue with the investigation of the financial capital and its institutions. Money, Wages and Trade in the Middle East. The hypothesis underlying this new monograph book is that beginning with the concentration and accumulation of financial wealth as a result of the plague demographic effect, there were changes in money, wages and trade. The monetization of wages, taxes, commodities, and market transactions established wage labor as the dominant system. The monetary, the wages and the trade were the more important economic areas to be impacted by this occurrence.

B. RESEARCH PROJECT

Numeracy and Literacy rate in the Middle East and North Africa

Abstract: The project hypothesis being that literacy and numeracy rates in Arabic speaking societies known for stupendous literary production before the printing press and mandatory schooling of children, may be gauged from the quantitative measurements of

Arabic books. In other words, that statistical techniques can produce literacy and numeracy rates by accounting manuscripts were produced in towns and consumed there applying to them various demographic measurements. Based on newly constructed data bases of Arabic manuscripts for the purpose and applying recently tested elsewhere techniques, the literacy rates maybe teased out. Through thematic classification of the manuscripts in our database it will be possible to prod the relevant implication of literacy to economic performance as related to knowledge distribution.
